Below are the details of the changes made to our latest software release.

Legislative

- PPP-7297 – New Afrikaans translations have been added for tax codes 3607, 3833, 3834, 4584, 4585 and 4586

Enhancements

- PPP-7179 – The PDF payslips sent to Sage Self Service will now be individually protected by the password entered on the employee masterfile.
- PPP-7281 – Sage Pastel Payroll has been adapted to enable installation and registrations of Pervasive Version 13.

Defects

- PPP-7292 – When creating a new company, you will no longer be asked to run a Legislative Release when logging in the first time.
- PPP-7298 – A rebuild will now be forced when changes are applied to calculation totals on transactions, to ensure they recalculate correctly.
- PPP-7299 – Setup Transactions has been corrected to amend the calculation totals in the respective pervasive tables for custom reporting purposes.
- PPP-7300 – Active companies will no longer reflect as 'Copy' on the File...Open screen.
- PPP-7304 – Employees will no longer be deselected for Sage Self Service when they are terminated in Sage Pastel Payroll.

Councils

- PPP-7278 – Road Freight – New transactions have been created for the taxation of council benefits.
- PPP-7284 – MIBCO – You will no longer get an error message when exporting the Transactions and Templates and reimporting them.
- PPP-7291 – MIBFA – The formula for the MIBFA council has been corrected and will no longer return an error if you do not have a Monthly pay frequency.
- PPP-7294 – MIBFA – The pension and provident fund percentages have been corrected.
- PPP-7301 – MIBFA - A new exception has been added to ensure that our customers have the correct benefit transactions added to the payslip.
- PPP-7302- Electrical – New transactions have been added for the taxation of the council benefits.
