Legislative

- PPP-7313 If nature of person = R, then ID is mandatory.
- PPP-7319 If nature of person = N and the country code = ZA, then Physical Address Postal code is no longer mandatory.
- PPP-7320 The electronic certificate export file has been amended to comply with the BRS V18.0.3 document and includes the following changes:
 - PPP-7325 Code 3040 will not export if Nature of person is D/E/F/G/ or H.

 - PPP-7351 If an employee selected for ETI does not qualify for ETI in a given month, then 7005 will export with 0.
 - PPP-7357, PPP-7328 & PPP-7334 If an employee is selected as a director (nature of person = C), then nature of person will export as either A or B, depending on the information available on the employee.
