## Release 5.2c: Patch Files (Release date 15 August 2019)

The following items have been resolved as part of the released patch files:

Item	Description of Issue
Email of Payslips and Reports	In some cases payslips and reports that are emailed did not reach the recipients. When emailing payslips and reports, the “from address” has been amended to: <a href="mailto:NoReply@sagepayrollprofessional.com">NoReply@sagepayrollprofessional.com</a>
Manage My Account email address	Modifying the login email address under the “My Account” option on the Subscription page resulted in no subscriptions showing.
Payslip Printing	The way we handle file locking when printing payslips in a multi-user environment has been addressed (where users are working on the payroll while another user is printing payslips)
Upload of Payroll Data	Upload of Payroll Data from Premier, Classic and Sage200c will now be available for all users with an active subscription.

## Release 5.2c: Patch Files (Release date 8 July 2019)

The following items have been resolved as part of the released patch files:

Item	Description of Issue
User Defined Payslip	Incorrect font size
User Defined Payslip	Every 60 <sup>th</sup> line prints a blank
Payslip Printing	File not found error when previewing large volumes of payslips
Payroll Register	When sorting the report, it prints multiple pages with only a few lines of information per page

History Screen	Change to Access on History Screen
Copy Company Structure	Invited consultant could not access a Copy Structure Company
ETI Import	Limit of R6 000 for ETI Remuneration used instead of R6 500
Changing a Dormant Company to Live	When trying to change a 'Dormant' company to 'Live' you get a message that you are over the Max Employee Limit and can, therefore, not make the required change.
Migrations	Watermark and Logo will be cleared when migrating data from Premier, Classic or Sage 200c
Migrations	PDF payslips not being emailed due to an incorrect back-end flag

Below find a brief summary of the above mentioned changes.

#### **RSA: New IRP5 Codes published by SARS**

From 1 March 2019 the following IRP5 Codes (as published in the BRS) are applicable:

3607	Overtime
3833	Bargaining Council Employer Contributions (PAYE)
3834	Loan to purchase immovable Residential Property (Excl)
4585	Employer's pension fund contributions paid for the benefit of an employee or former employee who has retired from the fund and qualifies for the "no value" provisions in the 7th Schedule [par 12D(6)]

4586 Employer's provident fund contributions paid for the benefit of an employee or former employee who has retired from the fund and qualifies for the "no value" provisions in the 7th Schedule [par 12D(6)]

We are not converting any Definition Lines, because we cannot establish which lines in the current setup are used for the items that now have dedicated IRP5 Codes. You need to allocate the IRP5 Codes on the applicable Definition Screens.

These new IRP5 Codes will only print on the IRP5 Certificates and IRP5 Submission File from Release 5.3a.

## Angola Tax Changes

We have catered for the amendments mentioned in the Angola Tax Act published on 24 April 2019.

## Africa Reporting

### o Botswana ITW8 Tax Certificate Layout Changes

The ITW8 Tax Certificate layout has been updated as per the latest requirements from BURS. It is a requirement to use the new layout for the 2018/2019 tax year end.

The pre-printed stationery did not change but the information printing on the certificate has been updated to align to the plain paper certificate.

### o Changes to Reports and Bank Files

Changes have been made to reports for: Ghana; Namibia; Nigeria; Rwanda and Swaziland

Bank File changes for Zimbabwe and a new bank is added for Kenya

## Report Maintenance: PDF Printing

Maintenance has been done on the PDF Creator utility currently in use.

## Loan Module

The Loan Module allows for the following:

- A configurable risk engine containing the following loan calculators:
  - o Affordability,
  - o Increase payments, and
  - o Shorter loan term.
- Flexible loan management features allowing for:
  - o Repayment holidays, and
  - o Rate and fee changes.

- An Employee Loan statement that can be printed on a monthly basis
